This notice explains what information we collect, when we collect it and how we use this. The purpose of this notice is to make you aware of how we will handle your information.

#### Who am I?

## How we collect information from you and what information we collect

We collect information about you:

- From your application to let your property through MM Sales & Lettings
- From signing MM Sales and Lettings' Agency Terms of Business

We collect the following information about you:

• Landlord's name, e-mail address, telephone number, address, bank account details;

# Why we need this information about you and how it will be used

We need your information and will use your information:

- to undertake and perform our obligations and duties to you in accordance with the terms of our contract with you;
- to enable us to supply you with the services and information which you have requested;
- to help you to manage your tenancy;
- to analyse the information we collect so that we can administer, support and improve and develop our business and the services we offer;

- to contact you in order to send you details of any changes to our or supplies which may affect you; and
- for all other purposes consistent with the proper performance of our operations and business.

## **Sharing of Your Information**

The information you provide to us will be treated by us as confidential and will be processed only by a third party, acting on our behalf, within the UK/EEA. We may disclose your information to other third parties who act for us for the purposes set out in this notice or for purposes approved by you, including the following:

- If we enter into a joint venture with or merged with a business entity, your information may be disclosed to our new business partners or owners;
- If you are unable to make payments under your agreement, your information may be disclosed to any relevant party assisting in the recovery of this debt or the tracing of you as a landlord; and
- In the creation, renewal or termination of the tenancy, your information will be disclosed to the relevant local authority, service/utility provider, factor, facilities manager or any other relevant person or organisation in connection with this.

Unless required to do so by law, we will not otherwise share, sell or distribute any of the information you provide to us without your consent.

## Transfers outside the UK and Europe

Your information will only be stored within the UK and EEA unless otherwise stated by MM Sales & Lettings and agreed upon with the person in question. At the time of this notice, all data will be stored within the UK and EEA.

Where information is transferred outside the UK or EEA, we ensure that there are adequate safeguards in place to protect your information in accordance with this notice, including the following:

- Decision by the Commission that the third country has adequate safeguards
- Details of appropriate security provisions in place.

#### Security

When you give us information we take steps to make sure that your personal information is kept secure and safe.

Location of our servers:

- Our primary server is in our office secured with a security code and lock (this is also where our paper copies are stored)
- Daily back up is located in Hythe all data is encrypted to a UK site
- Weekly back up goes to an encrypted server/site in Frankfurt
